

GUIDELINES FOR AUTHORS

PHARMABUZZ- A National monthly magazine publishes review articles relevant to pharmaceutical sciences, original articles, news and views, case reports of substantive value, invited editorial annotations, invited paper on recent advances (Clinical Research, Nanotechnology, New Chemical Entity, Novel Drug Delivery System, Biopharma, Bioinformatics, Biomedical/ Latest Manufacturing Practices, Natural Product Chemistry), announcements; summary reports of conferences and book reviews.

All manuscripts submitted to the PHARMABUZZ should not have been published in any form in any other publication, and become the property of the publishers. All manuscripts must be accompanied by the following written statement signed by all the authors. The undersigned authors (s) certify (ies) that the article is original, is not under consideration by any other journal, and has not been previously published. All copyright ownership of the manuscript entitled (title of the article) is hereby transferred to the publishers of the PHARMABUZZ. Articles will be edited for style and grammar.

All statement and opinions expressed in the manuscripts are those of the authors and not those of editor (s) or publishers. The editor (s) and publishers disclaim any responsibility for such material. The editor (s) and publishers also do not guarantee, warrant or endorse any product or service advertised in the Magazine, nor do they guarantee any claim made by the manufacturer of such product service.

Form of Manuscript

Title Page: This should include the manuscript's full title, author's name, institutional affiliations, 5 key words for use by abstracting services, and a running title of not more than 40 characters. **Abstract:** On a separate page, provide a summary of not more than 250 words. **Introduction:** This should state the paper's objective briefly and clearly with reference to previous work. **Methods** These should be described in sufficient details. **Results:** These should be described concisely and in logical order. Where possible, use figures or tables to present data rather than text. **Discussion:** This section should interpret the results and assesses their significance in relation to previous work in the field. Avoid speculation not warranted by actual data. **Acknowledgements:** These should be typed on a separate sheet and kept to a minimum consistent with the requirements of courtesy and disclosure. **References:** Effective with all new submissions cite references by number in text.

Proofs and Reprints: Proofs must be returned within 3 days of receipt. Late return of proofs may cause publication of the article to be delayed. Please check text, tables, legends, and references carefully.

Electronic Submission

Electronic submission of manuscripts is strongly encouraged, provided that the text, tables, and figures are included in a single Microsoft Word file. Please send your valued contributions to support@pharmabuzz.org
